

Privacy policy of the website www.sunuviesnica.lv

1. The Internet site www.sunuviesnica.lv (hereinafter referred to as the Site) collects data about Site visitors, thus enabling the Website maintainer to evaluate the usefulness of the Site and how it can be improved.
 2. The controller, who collects data about Site visitors, is Inc. Kalndores, Reg.No. 4200051800, (hereinafter referred to as the Controller).

 4. The Controller continuously upgrades the Site in order to improve its use, so the Controller needs to know what information is relevant to the Site's visitors, how often they visit the Site, what kind of devices and browser they use, the region they come from and what kind of content is read the most.
 5. The Controller uses Google Analytics, which enables the Controller to analyze how visitors use the Site. Find out how the Google Analytics basic principles work on Google website https://support.google.com/analytics/answer/1012034?hl=en&ref_topic=6157800.
- The Controller uses the data collected in their legal interest in order to improve the understanding of the needs of the Site's visitors and improve the availability of the information published by the Controller. At any time, the visitor may stop collecting data for Google Analytics, as described here: <https://tools.google.com/dlpage/gaoptout/>.
6. The server, on which the Site is hosted, can register visitor-sent requests (device used, browser, IP address, access date and time). The data referred to in this paragraph is used for technical purposes: to ensure the proper functioning and security of the Site and to investigate possible security incidents.
 7. Cookies are small files which, whenever a visitor visits the Site, are saved by the browser to the visitor's computer to the extent specified in the visitor's computer's browser settings. Separate cookies are used to select and apply the information and promotions offered to the visitor based on the content that the visitor viewed earlier, and thus to make the use of the Site easy, convenient and tailor-made for visitors.  8. The Site uses cookies to collect user IP addresses and browsing information and allow the Site to remember the visitor's choice. Cookies allow the Controller to track Site traffic and user interaction with the Site. The Controller uses these data to analyze visitor behavior and improve the Site. The legal basis for the use of cookies is the Controller's legitimate interest in providing the Site's functionality, availability and integrity.
 9. The visitor can control and / or delete cookies of their choice. More information about this process is available at www.aboutcookies.org. The visitor can delete all cookies that are

on their computer, and most browsers can be set up to block cookies on the computer. A visitor may opt out of cookies in the browser menu or at <https://tools.google.com/dlpage/gaoptout>. In order to make the necessary settings, the visitor needs to familiarize themselves with the rules of their browser. In case of cookie blocking, the visitor will have to adjust the settings manually each time the Site is visited, and there is a risk that some services and features will not work.

10. Only employees of the Controller who are responsible for analyzing such data can access the Site visitor statistics.

11. Unless otherwise stated, cookies are stored while the activity, for which purpose they are collected, is being executed, and then deleted.

12. The Controller confirms that cookies and statistical information will be collected, processed and stored in accordance with the requirements of the European Union regulatory enactments, including the Personal Data Protection Regulation of the European Parliament and the Council of the European Union of 27 April 2016 No. 2016/679.

13. The Controller reserves the right to change these terms at any time. The Site visitor has the obligation to independently check the content of the site to familiarize themselves with the changes to the rules.
